IDT plans are available at individual or family rates. A family rate covers the Named Member, Named Member's spouse and up to 10 dependent children under the age of 18. It also provides consultation and restoration services for dependent children ages 18 to 26 who permanently live in the same residence as the Named Member. A \$1 million insurance policy is issued through a nationally recognized carrier and covers certain costs incurred as a result of a stolen identity event. LegalShield/IDT is not an insurance carrier.
