TEAM MEMBER (Dress Code Policy)

The dress code for TCL Financial & Tax Services is professional dress attire. All clothing should be ironed and wrinkle free.

BLOUSES, SHIRTS, AND TOPS

- No Camisole Blouses, Shirts, or Tops (unless fully covered with a blazer, cardigan, or sweater)
- No Denim Blouses, Shirts, or Tops (Monday through Thursday)
- No Halter Blouses, Shirts, or Tops
- No Jogging Blouses, Shirts, or Tops
- No Revealing Blouses, Shirts, or Tops (stomach and/or undergarments should never be visible)
- No Scrub Blouses, Shirts, or Tops
- No Short Blouses, Shirts, or Tops (stomach and/or undergarments should never be visible)
- No Sleeveless Blouses, Shirts, or Tops (unless fully covered with a blazer, cardigan, or sweater)
- No Strapless Blouses, Shirts, or Tops
- No Sweat Blouses, Shirts, or Tops
- No Tank Tops (unless fully covered with a blazer, cardigan, or sweater)
- No T-Shirts
- No Tube Blouses, Shirts, or Tops
- No Wind Blouses, Shirts, or Tops
- No Yoga Blouses, Shirts, or Tops

BOTTOMS, JEANS, AND PANTS

- No Cargo Bottoms, Jeans, or Pants
- No Denim Bottoms, Jeans, or Pants (Monday through Thursday)
- No Jeggings (Monday through Thursday)
- No Jogging Bottoms, Jeans, or Pants
- No Legging Bottoms, Jeans, or Pants (unless worn with a blouse, dress, shirt, or top to the length of your fingertips)
- No Multi-Colored Jeans
- No Ripped Bottoms, Jeans, or Pants
- No Sagging Bottoms, Jeans, or Pants
- No Scrub Bottoms, Jeans, or Pants
- No Shorts
- No Skorts
- No Stretch Bottoms, Jeans, or Pants (unless worn with a blouse, dress, shirt, or top to the length of your fingertips)

- No Sweat Bottoms, Jeans, or Pants
- No Wind Bottoms, Jeans, or Pants
- No Yoga Bottoms, Jeans, or Pants

DRESSES AND SKIRTS

- No Short Dresses (must be the length of your fingertips when standing)
- No Short Skirts (must be the length of your fingertips when standing)

SANDALS AND SHOES

- No Croc Sandals or Shoes
- No Flat, Open Toe Sandals (must have a heel)
- No Flip Flop Sandals or Shoes
- No Shower Sandals or Shoes
- No Tennis Shoes

OTHER

- No Denim (Monday through Thursday)
- No Distractive Colored Hair
- No Excessive Jewelry
- No Extremely Long Eyelashes
- No Extremely Long Fingernails
- No Extremely Tight Fitting Clothing
- No Headwear
- No Overalls
- No Ungroomed Facial Hair
- No Ungroomed Hair
- No Visible Body Piercings (does not include women wearing earrings)
- No Visible Tattoos

FRIDAY DRESS CODE

- All Items Stated Above Apply
- Denim Can Be Worn
- Jeggings Can Be Worn (must be worn with a blouse, dress, shirt, or top to the length of your fingertips)

SATURDAY DRESS CODE

- All Items Stated Above Apply
- Company Logo Blazer (does not have to be worn)
- Denim Can Be Worn
- Jeggings Can Be Worn (must be worn with a blouse, dress, shirt, or top to the length of your fingertips)

PERSONAL HYGIENE

• Due to the close interaction and proximity to clients and other Team Members, good personal hygiene is required at all times while present at work.

DURING TAX SEASON

- All Items Stated Above Apply
- Company Logo Blazer (must be worn Monday through Friday)
- Name Badge (must be worn at all times)

POST TAX SEASON

- All Items Stated Above Apply
- Company Logo Blazer (only worn on days designated by the company)
- Name Badge (must be worn at all times)
